PHASE TWO OCCURED IN 2012, WHICH INCLUDED A WRITING CURRICULUM WITH A GOLDEN RULE LESSON FOR ALL GRADE LEVELS TIED TO ARIZONA STATE STANDARDS AND PERFORMANCE OBJECTIVES FOR MUSIC, DRAMA, ART, WHCIH ARE BEING LAYERED INTO MANY ACTIVITIES.
